## Important Information from the Santa Clara County Assessor's Office

Thank you for joining the tens of thousands of businesses that e-filed their business property statement (571-L) with the Santa Clara County Assessor's Office. The information you provided was used to determine the assessed value of your business personal property (machinery and equipment, computers, etc.). Earlier this week the Tax Collector's Office began mailing annual property tax bills based upon these assessments.

As a benefit to taxpayers who filed online, I am pleased to announce that this year the Assessor's Office is making available for download, a copy of property statements that were timely e-filed. For the first time, Santa Clara County business taxpayers can download a copy of a special report documenting the underlying basis for the enrolled assessed values. This report is specific to your company and shows the costs by categories as reported on your property statement, the depreciation schedules applied to each of these categories, and the extended assessed values that result in the full cash value (FCV). It also shows the mailing and situs address, the associated parcel number, a summary of the past four years of enrolled values and comparison to last year. On the website we have also provided a sample report annotated with helpful explanations.

To download either statement, go to <a href="www.sccassessor.org/efile">www.sccassessor.org/efile</a>. Taxpayers will need the account and BIN (business identification number) used when they e-filed earlier this year to access the e-filing website. To protect your privacy, it is necessary to go online to receive this information, similar to online banking. This information is not available to business owners with leased equipment, or businesses that failed to file timely, did not file electronically, closed their business, or provided incomplete information.
