Santa Clara County Assessor Special Election Certified by Board of Supervisors, Neysa Fligor Sworn in as Santa Clara County Assessor

Tuesday, January 27, Santa Clara County, California: On Monday, January 26, the Santa Clara County Board of Supervisors certified the results of the December 30, 2025, run-off special election for Assessor, confirming the election of Neysa Fligor to the position. Assessor Neysa Fligor took the oath of office the same day and was sworn in as the 23rd Santa Clara County Assessor.

A California State Board of Equalization Certified Property Tax Appraiser, graduate of Georgetown Law, former attorney for the Assessor's Office and member of the Assessor's Executive Management Team since 2024, Assessor Fligor brings expertise and experience that will allow her to seamlessly transition to the top leadership position in the Assessor's Office. Assessor Fligor's election was also historic as she is the first female to be elected Santa Clara County Assessor, and the first Black/African-American female assessor in the State of California.

At her swearing-in ceremony, Assessor Fligor shared, "I am excited and honored to be the next Santa Clara County Assessor. Along with the amazing team in the Assessor's Office, I will work to ensure that the Assessor's Office continues to work for taxpayers and residents. I am ready to get started on day one." She reiterated her priorities for the Office: Ensuring assessments are conducted fairly, legally, and accurately, protecting revenues, improving processes to better serve taxpayers and residents, and increasing community engagement across the County. She will continue to play a key role in overseeing the implementation of the modern technology property assessment solution, after successfully managing the acquisition process in 2024. She looks forward to its implementation stating, "it will result in faster service, higher data quality, improved access, enhanced security and ultimately improved service delivery to the public."

During the period following former Assessor Larry Stone's retirement and the certification of the special election, Greg Monteverde was appointed by the Santa Clara County Board of Supervisors to be the Acting Assessor. During his 35-year tenure with the Assessor's Office, Monteverde built a reputation as an effective and forward-thinking leader. Monteverde's leadership was crucial for operational continuity during the transition period. Greg will return to his role as Assistant Assessor and looks forward to continuing to work with Neysa. "It has been an honor to lead the office and serve as Assessor during this time of change, and I am excited to pass the torch to Neysa. I am confident that her integrity, intelligence, and compassion, combined with our support, will provide for the continued success of our office. I look forward to resuming my traditional duties as Assistant Assessor, as well as managing the implementation process for the new technology solution," Greg said.
